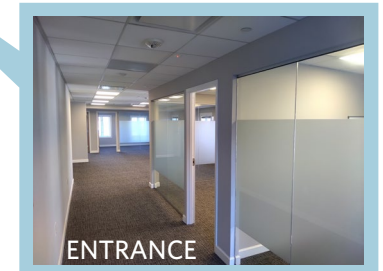
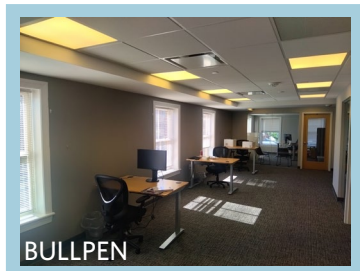
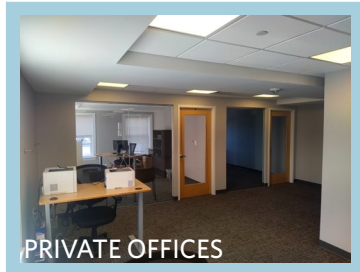

Suite 330 | 1,450 RSF



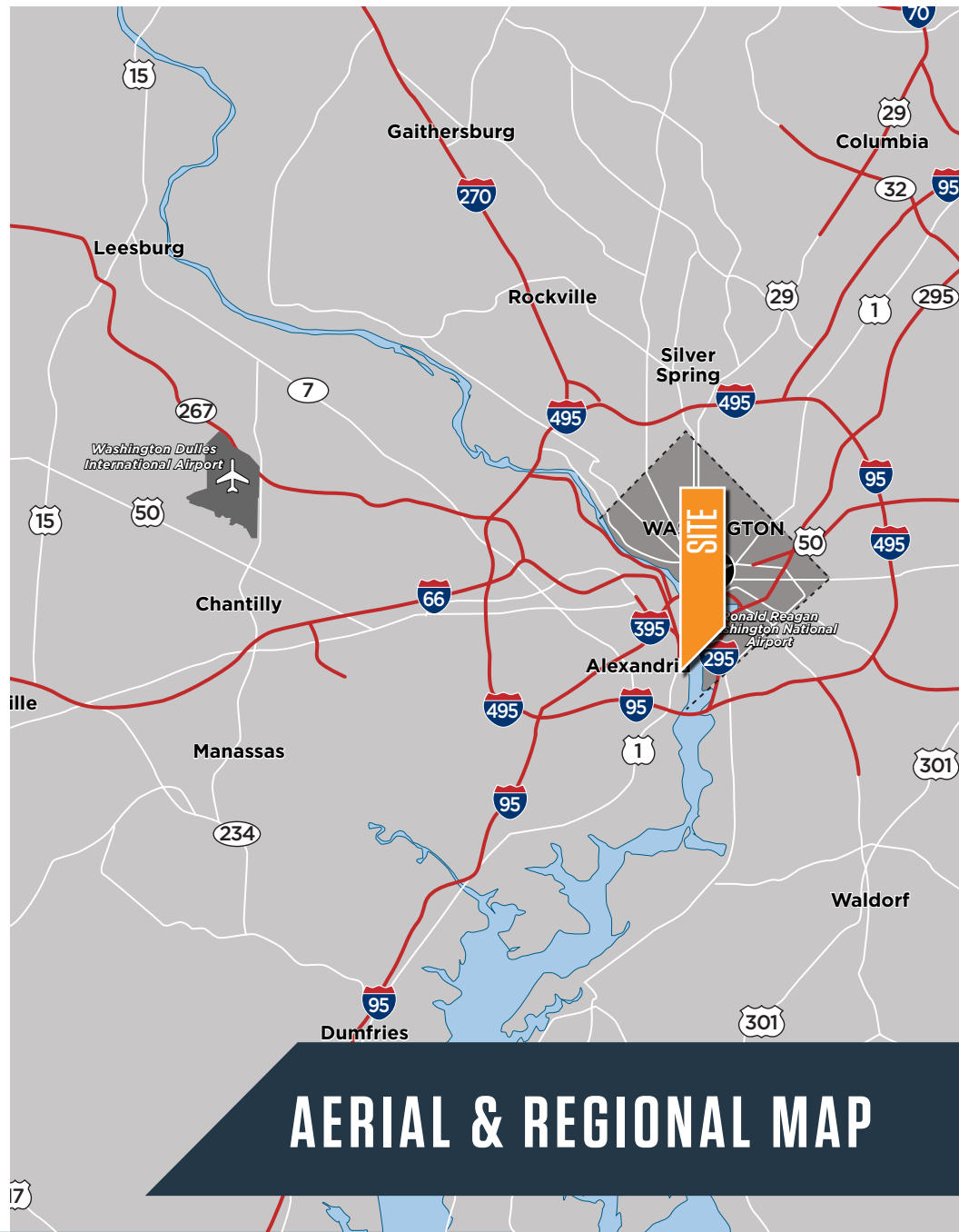
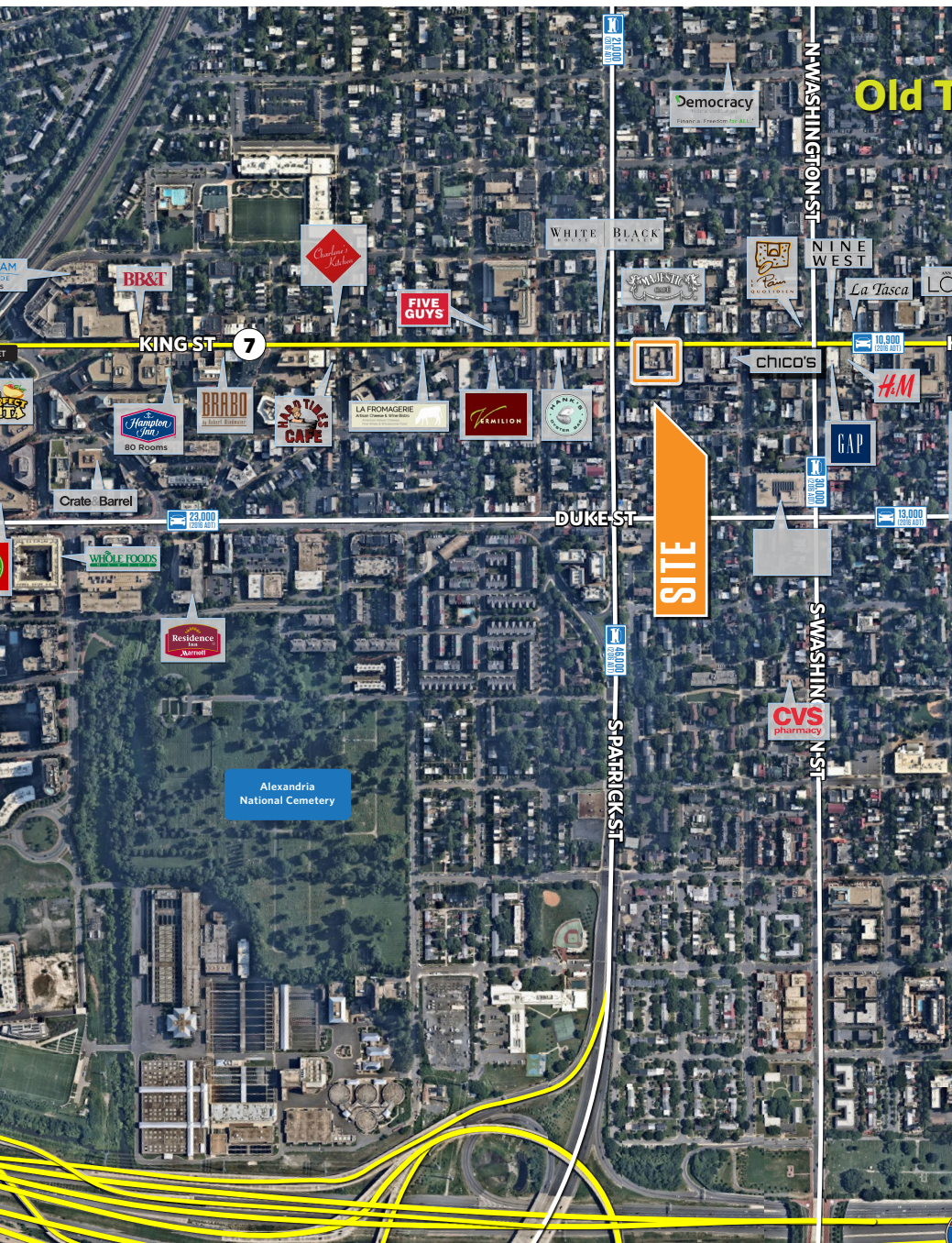
