



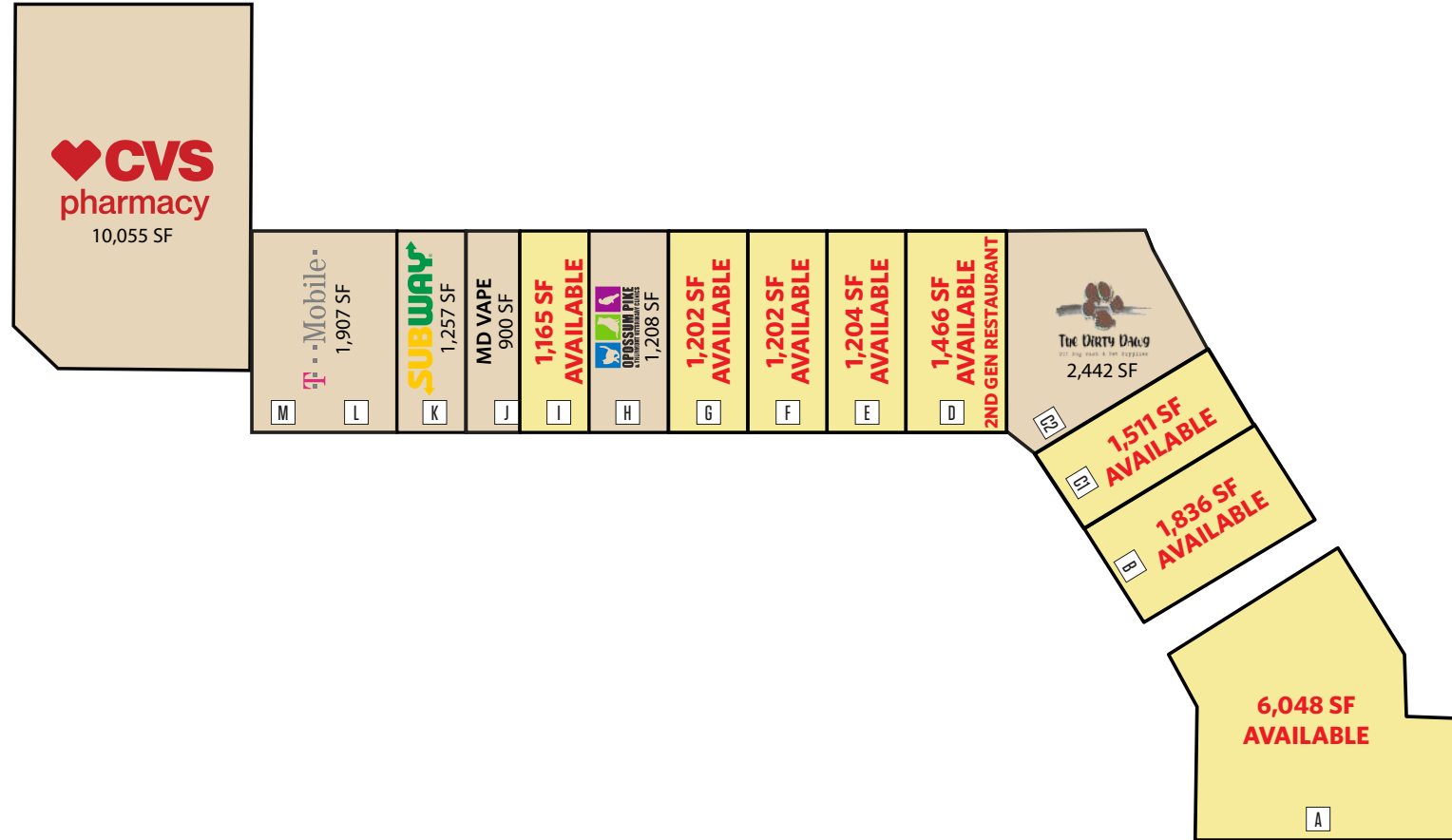
SITE PLAN

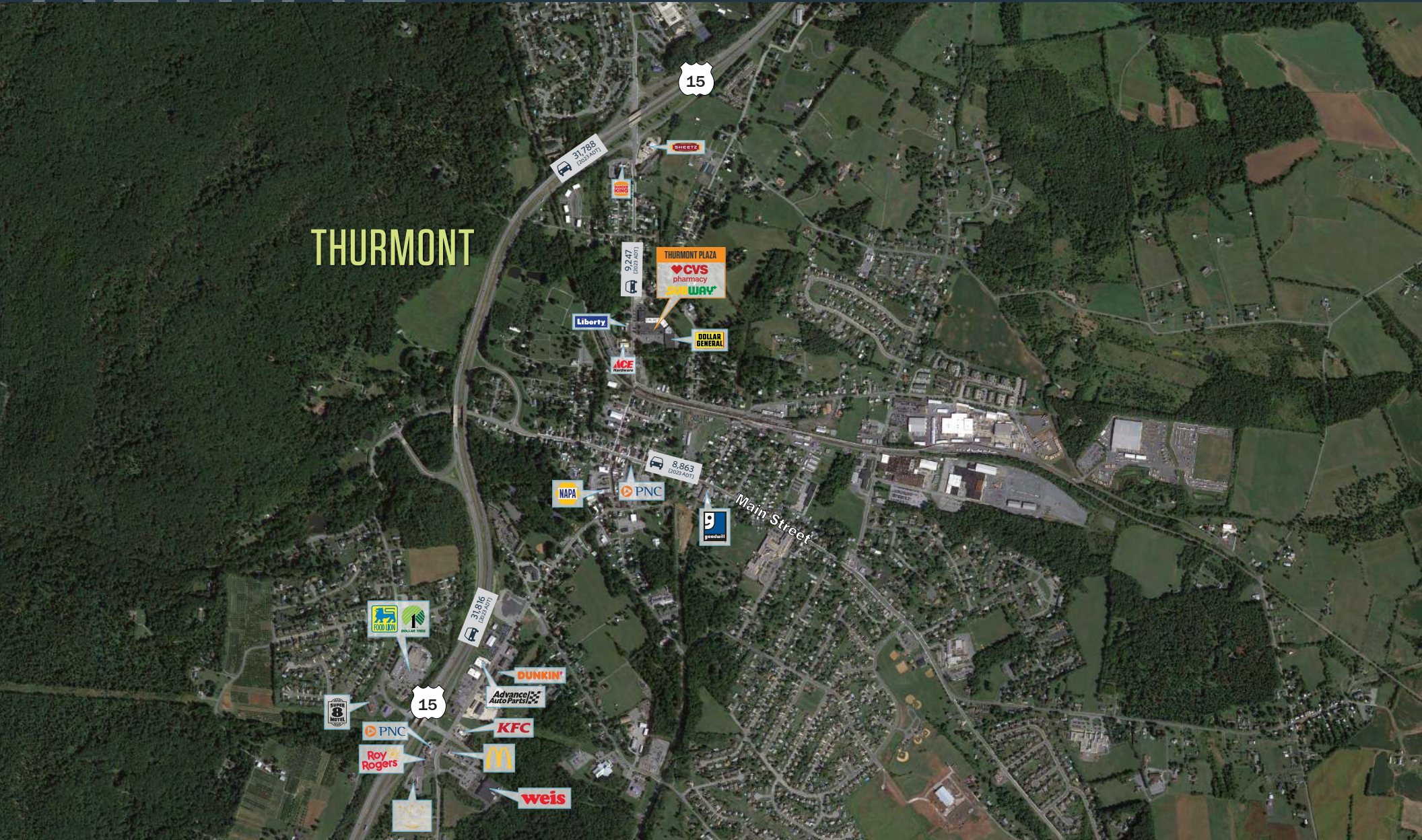
