- **49,080 SF Warehouse:** Would consider demising as small as 20,000 SF
- Fully air-conditioned with heavy power (3,000 amps, 277/480v, 3 phase) and 18' clear height; highly secure space
- 8 dock doors total; 4 interior platform docks, 3 covered dock positions, and 1 oversized door with contiguous fenced storage
- Perfect for distribution, climate-controlled manufacturing, food use, or showroom warehouse with retail component
- Small office/showroom with large manufacturing warehouse & fenced outside storage
- Potential for up to 2.5 acres of excess yard

- 3.11 acres (approx. 2.5 usable and partially fenced/paved at this time)
- Electric / water source for office trailer or build-to-suit
- Over 400' of frontage on highly-traveled Central Avenue (53,460 ADT)
- Less than a ½ mile from I-495 interchange and new Hampton Park redevelopment (500,000 SF mixed-use for Phase I)
- IE zoning allows for wide range of uses (industrial, storage yard, fleet maintenance, food, auto sales, etc.)

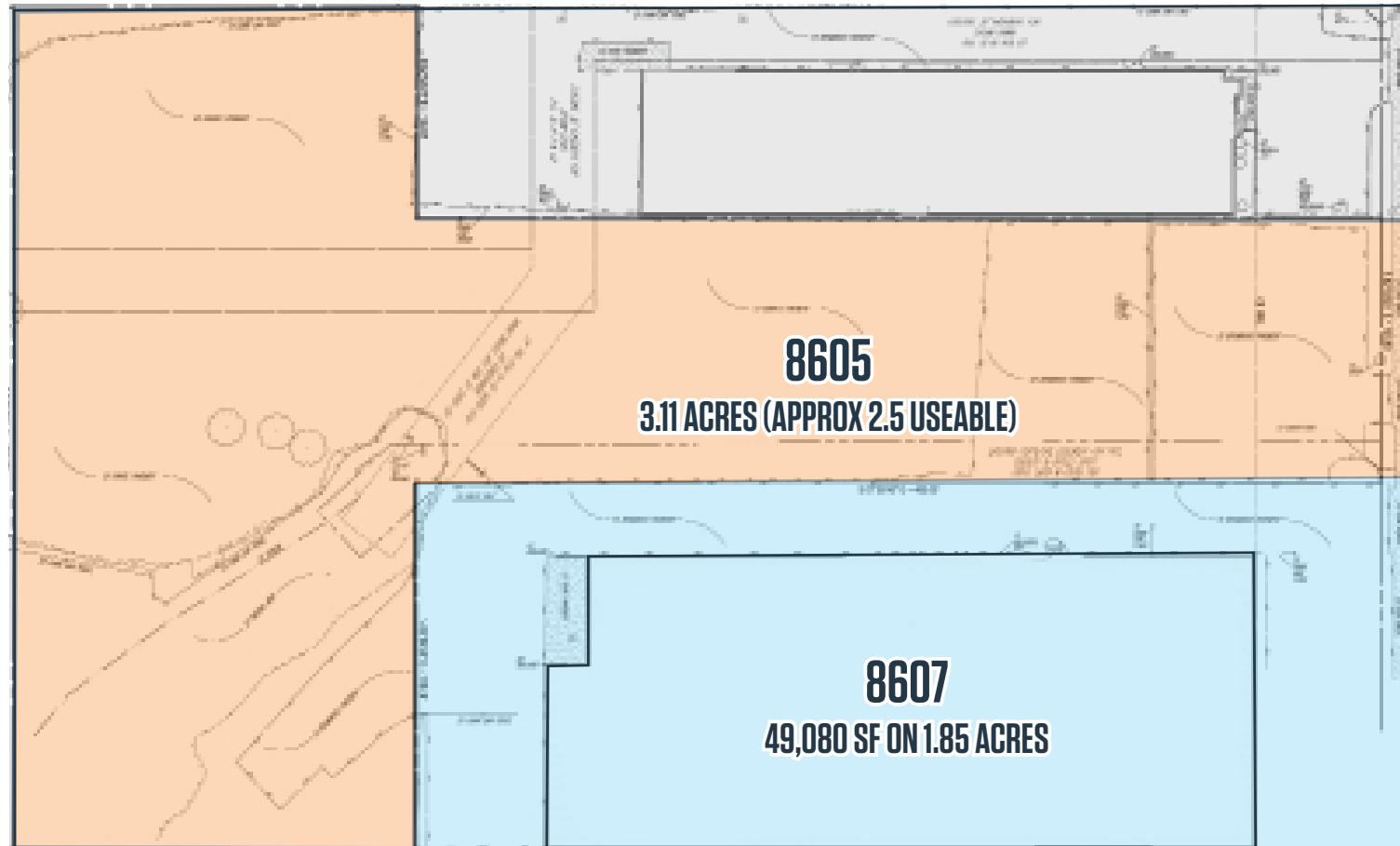

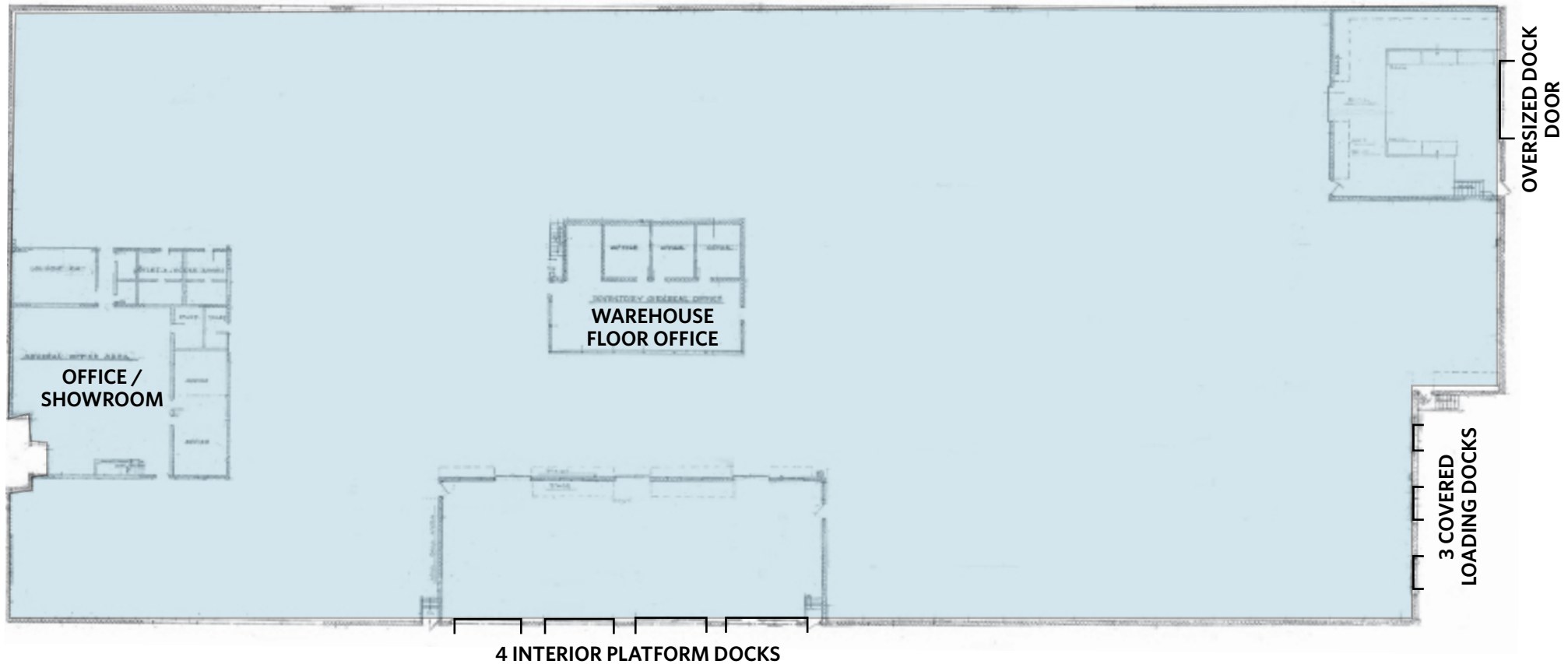

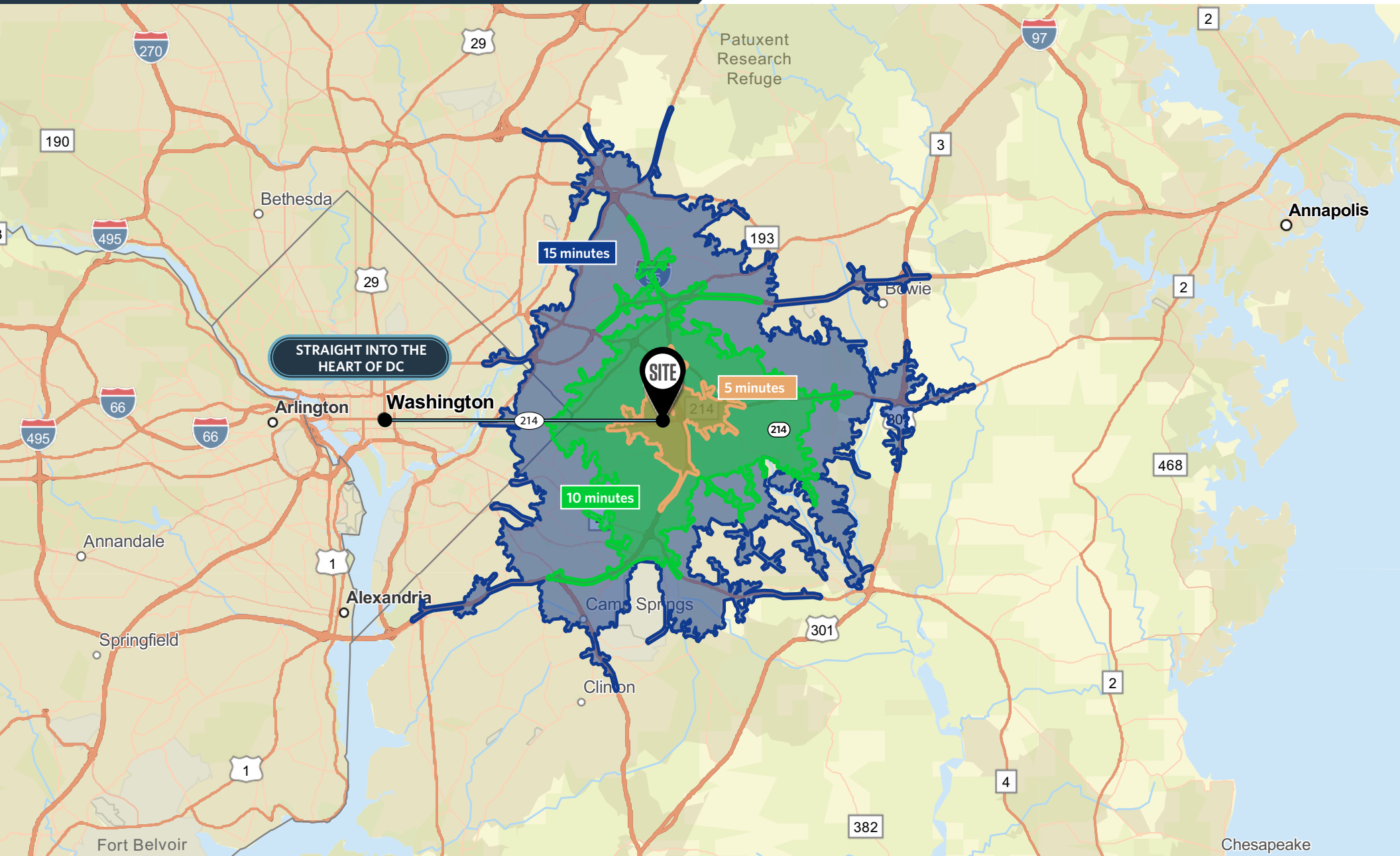

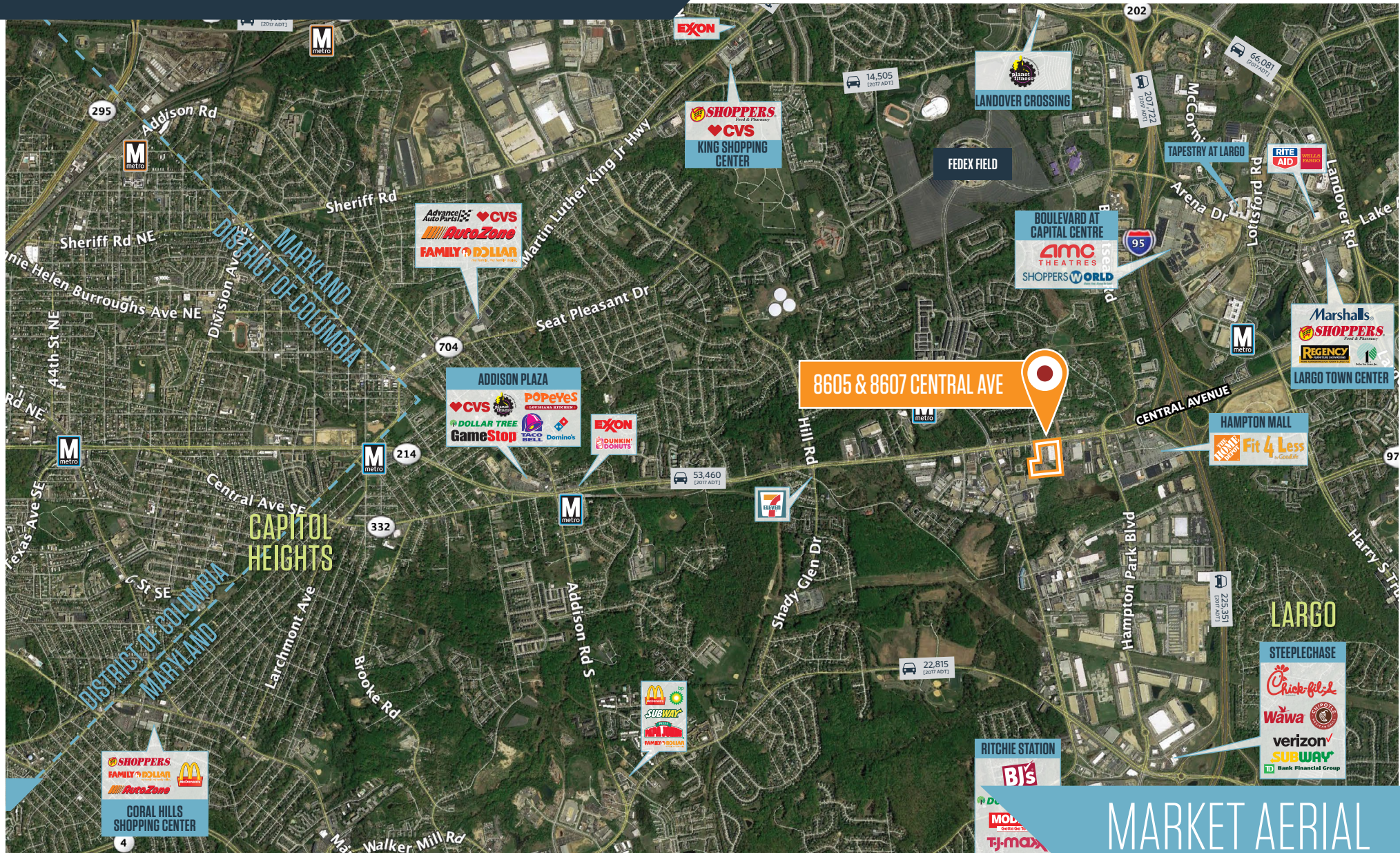

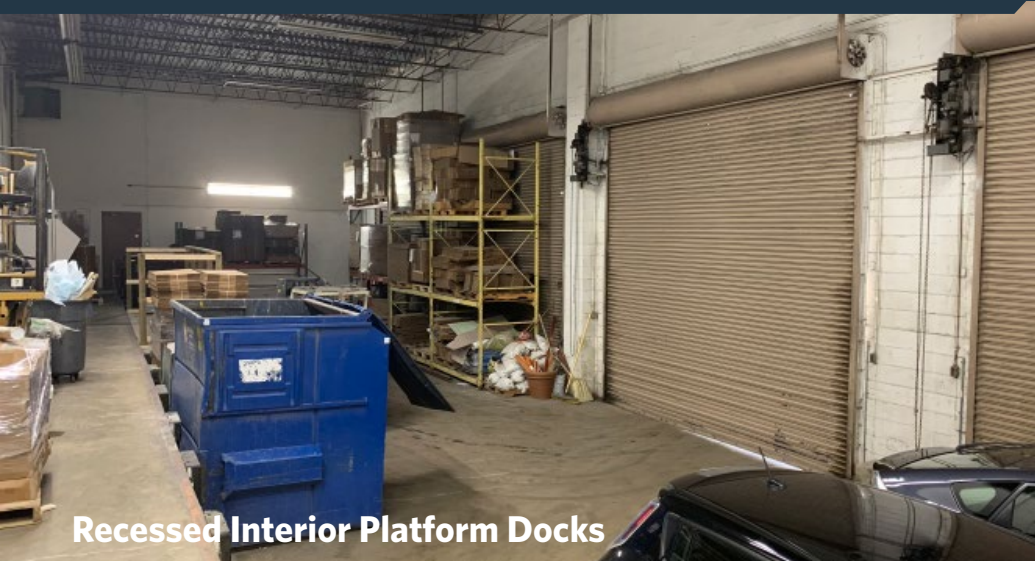
